### Mass Approval / Quick Approval:

**Mass Approval** is the process to review, amend and approve multiple draft BL's, whereas **Quick Approval** is the process to directly approve multiple draft BL's without reviewing them.

Select more than one BL's in **Draft to be Reviewed** screen and click on **Mass Approval** under **Actions** menu as shown below to open Mass Approval screen.
