Offloading charges will be applicable as mentioned below:

Allotment/Reservation Cases:

From the date of container allotment till the cancellation of Booking / Job Order & Seal wherever applicable. Pick up Cases: From the date of container pick up till the date of empty return, back to the pick-up location. ADDITIONALLY, Booking Cancellation fee will be charged at INR 3000/- per cancelled booking, where the full shipment is cancelled.

In addition, following cost will be charged separately:

- a) Storage charges will be applicable in case of allotted/reserved containers @ INR 250/-per Day per TEU.
- b) If container is picked up, Lift on/off charges at depot/ICD will be charged at prevailing published tariff of the facility except for the Nhava Sheva, Ludhiana, Jaipur and Chennai for which charges will be applicable as per our local tariff.
- c) Washing charges, if applicable as per tariff.
- d) Mandatory PTI charges for picked up reefer container @ INR 1500 per unit.
- e) Repairs if any, in case container is damaged by customer.
