- Demurrage & Detention Charges will be debited as Per standard tariff available on request & on our website.
- The tariff will be posted in our offices at the BL counter and our website.
- Where charges are imposed by terminals or other authorities, CMA CGM reserves the right to debit the customer back as needed.
- E-commerce BL fees will be applicable ONLY when the booking placed, SI submissions, E-Invoice & Draft reviewed on Web & Web BL release are done through CMA CGM website
- AMENDMENT PROCESS: 1 free amendment after vessel ETD / as from 2nd amendment – to be charged.
- LATE B/L & D/O Pick up:** Settle all charges (including ocean freight and local charges) within 7 days after vessel departure from Yangon / vessel arrival in Yangon. The charge will be collected weekly as per quantum announced below.
 - 8 to 14 days delay: MMK 35 000 (Invoice amount < USD 500) or MMK 50 000 (Invoice amount > USD 501)
 - 15 to 21 days delay: MMK 70 000 (Invoice amount < USD 500) or MMK 100 000 (Invoice amount > USD 501)
 - 22 to 29 days delay : MMK 105 000 (Invoice amount < USD 500) or MMK 150 000 (Invoice amount > USD 501)
 - 30 days onwards : MMK 140 000 (Invoice amount < USD 500) or MMK 200 000 (Invoice amount > USD 501)
