Pick up Cases: From the date of container pick up till the date of empty return, back to the pick-up location. ADDITIONALLY, Booking Cancellation fee will be charged as per the Local tariff per cancelled booking, where the full shipment is cancelled.

- Storage charges will be applicable in case of allotted/reserved containers @ INR 250/-per Day per TEU.
- If container is picked up, Lift on/off charges at depot/ICD will be charged at prevailing published tariff of the facility (annexure of tariff attached in the advisory itself).
- Washing charges, if applicable as per tariff.
- Mandatory PTI charges for picked up reefer container @ INR 1500 per unit.
- Repairs if any, in case container is damaged by customer.
